1. Introduction

1.1. What's in the Package?

Your package Home Arena Speaker System includes the following documentation and hardware:

- 2 x 2 way speakers with 1 x wire remote control
- ➤ 1 x AC-DC Adaptor 230V/12V

PC Soundcard with 3,5 mm stereo output or 3,5 mm stereo build in output

2. Installation

2.1. Front View HomeArena Stereo



(picture just for illustration)

2.2. Back View HomeArena Stereo



(primary speaker) (controller/On/Off//Volume) (cable left speaker) (AC/DC adapter) (left speaker)

2.3. Installation Instructions for HomeArena Stereo

- 1. Place the speaker with the controls (primary speaker) on the right side and other speaker (left speaker) on the left side of the PC monitor.
- 2. Plug the cable of the left speaker into the connector of the primary speaker.



- 3. Connect the 3.5 mm chinch cable to the sound card or any other audio source.
- 4. Before connecting the power cable, make sure the speaker's power controller is in the "off" or "out" position.
- 5. Plug the power adapter cable into the back connector of the primary speaker.



- 6. Connect the power adapter cable to a standard household electrical outlet.
- 7. Use the controller to turn on the speakers. The green LED Light should illuminate.

8. Activate the audio source to test speakers.	

3. Operating Instructions for HomeArena Stereo

- 1. Avoid exposing speakers to environments that are excessively warm and humid (particularly in unventilated spaces or nearby heaters) or dusty.
- 2. Do not set speakers near windows exposed to direct sunlight or in areas near to water
- 3. Clean speaker housing by wiping with mild cleaning solution. Do not use solvents!
- 4. The loudspeakers are magnetically shielded and you can place them also in the near of your PC monitor.
- 5. "!" Warning: Before connecting or disconnecting the loudspeakers from the main electricity make sure that the speaker's control button is in the "OFF" position.
